## RESOLUTION

- Authorizing the President Staff and Funding for Positions Immediately to Carryout the Duties of the Office of President to Include an Executive Secretary Under the President and a File Clerk for Filing and Archiving
- **WHEREAS,** the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and
- **WHEREAS**, the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and
- **WHEREAS,** Article III of the Wichita Governing Resolution affirms that the Wichita and Affiliated Tribes Council is the Tribe's supreme governing body; and
- **WHEREAS,** the Council may transact any other business which may come REGULARLY before it at its annual meeting; and
- WHEREAS, Article V of the Wichita Governing Resolution authorizes the Wichita Executive Committee to transact business and otherwise speak or act on behalf of the Tribe in all matters on which the Tribe is empowered to act now or in the future; and
- **WHEREAS,** Administration currently consists of support staff that includes an Administrative Assiant, Receptionist and a part-time position; and
- **WHEREAS,** the Administration eleven (11) years ago had the same support staff with the exception of the part-tim Secretary; and
- **WHEREAS,** since that time the Tribe has grown enoroumously and while the President does not deal directly daily with all of the entities, businesses, and programs the President is still responsible for the general oversight of the affairs of the Council which includes anything under the Tribal umbrella; and

- **WHEREAS,** in the last seven (7) years we have added land, hotel, history center, travel plaza, event center, readiness center, tribal member health plan, additional programs, additional staff and have grown well beyond the staff that is currently in place; and
- WHEREAS, due to political turmoil it is imperative that the President have an Executive Secretary hired by the President and under the President's direct supervision to ensure that political turmoil does interfere with the everyday business and not hired by the Wichita Executive Committee creating several supervisors which causes potential conflict; and
- **WHEREAS,** in addition there is a need to hire a person who is solely dedicated to filing tribal correspondence and archiving that correspondence and due to the importance of this it needs to be a full time position dedicated to creating a system that ensures that documents can be found and are properly filed for the next administration; and
- WHEREAS, due to the recent political turmoil, the current President desires that the Wichita General Council approve these positions due to the conflict that has been most obvious during the recent Recall Hearing held n Saturday, July 13, 2019 and has prevented the hiring of an Executive Secretary due to certain Committee Members instance that they be the ones that select the Executive Secretary.

**NOW THEREFORE BE IT RESOLVED,** that it is the will of the Council of the Wichita and Affiliated Tribes that the President of the Wichita and Affiliated Tribes be authorized to hire an Executive Secretary and File Clerk to be hired by the President and under the direct supervision of the President.

**BE IT FURTHER RESOLVED**, that this Resolution shall be continuing unless and until rescinded by separate action of this body, and shall supersede any and all prior resolutions or Executive Committee actions to the extent such actions conflict with the authorities granted by this Resolution.
