The equipment will be returned to the Education Services Department at the end of each semester/ academic school year unless otherwise sooner if the student is discharged from the program prior to the end of the program's last day. Students who do not return the Chromebook/mobile hotspot and related materials when requested may be subject to owing the tribe approximately **\$280.00** for the cost of the Chromebook/mobile hotspot; this will include suspension from education programs until amount is paid back to The Wichita and Affiliated Tribes. If the equipment is lost, stolen or damaged while in the borrower's possession, the borrower is responsible for the replacement or repair thereof and agrees to protect the Wichita Tribe Education Services Department against any claim occurring during or resulting from Borrower's possession. To include, but not limited to any claim for infringement or violation of applicable trademarks and copyrights attributable to borrower's use of the Education Services Department's property. Borrower may use the Chromebook/mobile hotspot only for non-commercial purposes, in accordance with the Education Services Department's policies and rules. Any included software may be used only in accordance with the applicable license and it is the Borrower's responsibility to be familiar with and to comply with the provisions of such license. The Education Services Department is not responsible for any computer or electronic viruses that may be transferred to or from borrower's device or other data storage medium. The borrower agrees to use their best efforts to assure the property is not damaged or rendered inoperable by any such electronic virus while in their possession. By signing below, borrower and/or borrower's parent/guardian acknowledge and agree to the terms of use as spelled out in the Chromebook/Mobile Hotspot Policy Summary and this Chromebook/Mobile Hotspot Loan Agreement Form. Student Responsibilities

Your Chromebook/mobile hotspot is an important learning tool and is for educational purposes only.
