RESOLUTION

Appointing Torrey Goombi to the Wichita Gaming Commission to fill an unexpired term ending May 31, 2026

- WHEREAS,** the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the “Tribe”) possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and
- WHEREAS,** the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and
- WHEREAS,** Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and
- WHEREAS,** the Wichita and Affiliated Tribes Gaming Ordinance was approved by the Wichita Executive Committee by Resolution WT-02-23, with a vote of 5 in favor, 0 opposed, and 0 abstentions on April 22, 2002; and
- WHEREAS,** said ordinance establishes a Tribal Gaming Commission whose duty is to regulate the tribal gaming operations and conduct oversight of all gaming activities to ensure compliance with federal, tribal, and if applicable, state laws and regulations; and
- WHEREAS,** said Commission shall be comprised of four (4) members; and currently there exists two (2) vacancies due to Ms. Angela Apauty, Secretary, whose term ended on May 31, 2024 and the resignation of Starr Chavez, Vice Chairman, whose term would have ended on May 31, 2026.
- WHEREAS,** the Wichita Executive Committee has advertised the position to notify tribal membership of the vacancy; and
- WHEREAS,** the Wichita Executive Committee desires to appoint Mr. Torrey Goombi to the Wichita Gaming Commission.

NOW THEREFORE BE IT RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby appoints Mr. Torrey Goombi to fill an unexpired term ending May 31, 2026, pending background clearance as approved by Resolution WT-13-67.

NOW THEREFORE BE IT FINALLY RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby authorizes the President or Vice President in the President’s absence to take all actions and execute all documents necessary to carry out the intent and purpose of this resolution.

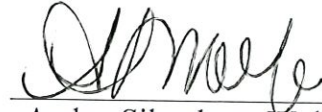
