RESOLUTION

Resolution of the Wichita Executive Committee directing the Anadarko Agency Bureau of Indian Affairs to process realty impacted by the American Indian Probate Reform Act (AIPRA)

WHEREAS, the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and

WHEREAS, the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and

WHEREAS, Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and

WHEREAS, The Wichita and Affiliated Tribes received fractionated land through probate under the AIPRA. The Wichita Executive Committee hereby finds it acceptable for the Anadarko Agency to proceed with profitable oil and gas leases, farming and grazing leases, and rights-of-way encumbrances on individual allotted trust properties where the Wichita and Affiliated Tribes inherited less than or equal to an undivided 10% interest through AIPRA probates; and

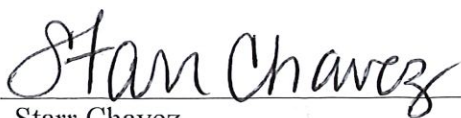
NOW THEREFORE BE IT RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby allows the Bureau of Indian Affairs to execute leases for farming and grazing, oil and gas leases, and right of way encumbrances on individual allotted trust properties where the Wichita and Affiliated Tribes inherited less than or equal to an undivided 10% interest through AIPRA probates.

NOW THEREFORE BE IT FINALLY RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby authorizes the President or Vice President in the President's absence to take all actions and execute all documents necessary to carry out the intent and purpose of this resolution.

CERTIFICATION

The foregoing resolution was adopted by the Wichita Executive Committee of the Wichita and Affiliated Tribes of Oklahoma on **October 8, 2024** in Anadarko, Oklahoma, by a vote of 4 for, 0 against, 0 abstentions, a quorum being present.
