RESOLUTION

To create a Lost Revenue Account standard allowance of \$10 million from COVID 19 related and tribal government funds

WHEREAS, the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and

WHEREAS, the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and

WHEREAS, Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and

WHEREAS, In order to address the need to fully obligate the remaining funds received from Treasury for ARPA and other public health emergency COVID-19; and

WHEREAS, The Wichita and Affiliated Tribes has determined that it would be in the best interest of the Tribe to create a Revenue Loss category under their SLFRF allocation up to the "standard allowance" of \$10 million.

NOW THEREFORE BE IT RESOLVED, that the Wichita and Affiliated Tribes approve the development of a Revenue Loss category for their State Local Fiscal Recovery Funds (SLFRF) allocation up to the "standard allowance" of \$10 million; and

BE IT FURTHER RESOLVED, that Finley Cook be authorized to create this category and transfer allocations from ARPA, Tribal Government and Tribal Self-Governance in lieu of calculating revenue loss; and

NOW THEREFORE BE IT FINALLY RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby authorizes the President or Vice President in the President's absence to take all actions and execute all documents necessary to carry out the intent and purpose of this resolution.

CERTIFICATION

The foregoing resolution was adopted by the Wichita Executive Committee of the Wichita and Affiliated Tribes of Oklahoma on **October 17, 2024**, in Anadarko, Oklahoma, by a vote of 4 for, 0 against, 0 abstentions, a quorum being present.
