RESOLUTION

Approving Wichita School Readiness Program (WSRP) Project Proposal

- WHEREAS,** the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and
- WHEREAS,** the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and
- WHEREAS,** Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and
- WHEREAS,** the Wichita Executive Committee is committed to creating and maintaining high quality childcare services; and
- WHEREAS,** the Wichita and Affiliated Tribes Child Care and Development Fund has received funding in the amount of \$7,354,922.00 to renovate or construct a childcare facility.
- WHEREAS,** this resolution supersedes resolution WT-25-42.

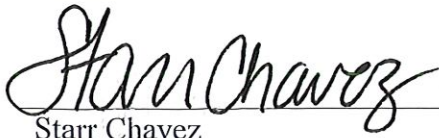
NOW THEREFORE BE IT RESOLVED, The Wichita and Affiliated Tribes Executive Committee authorizes the WSRP Project Proposal to demolish and rebuild the Wichita School Readiness Program with the support and advice of the Army Corp of Engineers utilizing funding from: GY 2021 CRRSA Construction and Major Renovation (21QKOKCYC5) \$1,910,134.00, GY 2021 ARP Stabilization Construction and Major Renovation (21QKOKCONTSC6) \$3,944,788.00, GY 2021 CCDF Discretionary Construction and Major Renovation (21QKOKCONT) \$750,000.00, GY 2022 CCDF Discretionary Construction and Major Renovation (22QKOKCONT) \$750,000.00.

BE IT FURTHER RESOLVED, the Executive Committee of the Wichita and Affiliated Tribes hereby authorizes the President or the Vice President in the President's absence to take all actions and execute all documents necessary to carry out the intent and purpose of this resolution.
