RESOLUTION

Approving the appointment of SAMUEL ALEX RIFFEL as Commissioner to a four-year term for the Wichita Tribe Industrial Development Commission.

- WHEREAS,** the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and
- WHEREAS,** the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and
- WHEREAS,** Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and
- WHEREAS,** the Act established and created the Wichita Tribal Industrial Development Commission which shall be composed of (5) members, and;
- WHEREAS,** there currently exists a vacancy; and
- WHEREAS,** the Commissioner position has been advertised and the Executive Committee reviewed the letters and resumes submitted by SAMUEL ALEX RIFFEL and other tribal members for the position; and
- WHEREAS,** The Wichita Executive Committee desires to appoint SAMUEL ALEX RIFFEL.

NOW THEREFORE BE IT RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby appoints SAMUEL ALEX RIFFEL to fill a four (4) year term expiring September 30, 2030, pending background clearance as approved by Resolution WT-13-67.

CERTIFICATION
