RESOLUTION

Approving the FY 2025 Cultural Preservation Board Budget

WHEREAS, the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the “Tribe”) possess substantial inherent sovereign powers and have exercised those powers since time immemorial; and

WHEREAS, the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and

WHEREAS, Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and

WHEREAS, the Wichita and Affiliated Tribes acknowledges cultural preservation as a priority in reclaiming and maintaining the cultural identity of the Kitikiti’sh people; and

WHEREAS, the Tribal Historic Preservation Act (the Act) was adopted by Resolution WT-23-099; and

WHEREAS, the Cultural Preservation Board was established under Chapter III, §3-301; and

WHEREAS, compensation for the Cultural Preservation Board is set forth in the Act under §3-307 “Compensation”;

NOW THEREFORE BE IT RESOLVED, that the Wichita and Affiliated Tribes approves the transfer of \$6,000.00 from Casino Revenue Account (0160) to the Wichita History Center Account (911) under Professional Fees (570500) for the purpose of funding the Cultural Preservation Board for FY 2025.

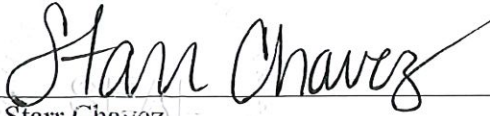
