RESOLUTION

Approving the appointment of CLINT PUNLEY as Commissioner to the Wichita Tribe Industrial Development Commission

WHEREAS, the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possess substantial inherent sovereign powers and have exercised those powers since time immemorial; and

WHEREAS, the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and

WHEREAS, Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and

WHEREAS, the Act established and created the Wichita Tribal Industrial Development Commission which shall be composed of (5) members, and;

WHEREAS, there currently exists a vacancy; and

WHEREAS, the Wichita Executive Committee desires to appoint CLINT PUNLEY.

NOW THEREFORE BE IT RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby appoints CLINT PUNLEY to fill a term expiring September 30, 2025, pending background clearance as approved by Resolution WT-13-67.

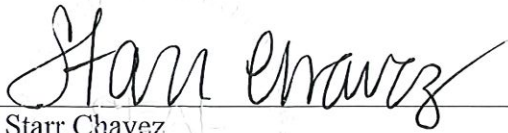
