RESOLUTION

Approving Carry-Over funding from Agreement for Inter-Governmental Cooperation with Caddo County

- WHEREAS,** the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and
- WHEREAS,** the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and
- WHEREAS,** Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and
- WHEREAS,** the Wichita and Affiliated Tribes Executive Committee acknowledges the need for well-maintained roads for the safety of their tribal citizens and the other residents of Caddo County, Oklahoma; and
- WHEREAS,** an inter-governmental agreement between the Wichita and Affiliated Tribes and Caddo County, Oklahoma was entered into March 31, 2022; and
- WHEREAS,** All funds have not yet been obligated for the general maintenance of the public roadways and cultural influenced areas listed on the Tribe's Tribal Transportation Program (TTP) route system; and
- WHEREAS,** the agreement allows for funds to be carried over by a resolution of the Wichita and Affiliated Tribes Executive Committee.

NOW THEREFORE BE IT RESOLVED, The Wichita and Affiliated Tribes Executive Committee approves the carryover of unobligated funds under the inter-governmental agreement to be obligated by March 31, 2026.

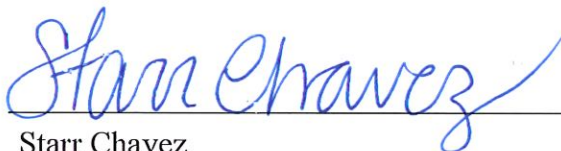
