RESOLUTION

Authorizing the closure of the Sports Commission account ending in #5987 held at Midfirst Bank

WHEREAS, the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and

WHEREAS, the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and

WHEREAS, Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and

WHEREAS, the Wichita and Affiliated Tribes Executive Committee has determined a need to close the Sports Commission account held at Midfirst Bank located in Anadarko, OK; and

WHEREAS, the account was established to support the activities of the Sports Commission; however, the commission is defunct and the account continues to accrue banking fees; and

WHEREAS, 48,000 Native students are currently enrolled in BIE-operated or Tribally Controlled Schools, which serve as the fulfillment of the federal government's trust responsibility to Indian education; and

WHEREAS, the Wichita and Affiliated Tribes Executive Committee desires to close the account and deposit the funds into the General Fund Account at Bank of Commerce; and

WHEREAS, on May 5, 2025 the Wichita and Affiliated Tribes Executive Committee came to consensus to close the account; and

WHEREAS, this resolution memorializes that consensus decision.

NOW THEREFORE BE IT RESOLVED, that the Wichita and Affiliated Tribes Executive Committee authorizes the Sports Commission account ending in #5987 at Midfirst Bank in Anadarko, OK be closed; and

BE IT FURTHER RESOLVED, that balance of approximately \$42,315.46 minus any account fees and including any accrued interest be deposited to the General Fund Account at Bank of Commerce in Anadarko, OK; and

BE IT FINALLY RESOLVED, the Wichita and Affiliated Tribes Executive Committee hereby authorizes President Amber Silverhorn-Wolfe or Vice President Tasha R. Mousseau in her absence, to sign this resolution.

CERTIFICATION
