RESOLUTION

To Establish a Purchase Card from Arvest Bank to Distribute Children's Clothing Assistance to Tribal Youth

- WHEREAS,** the Wichita and Affiliated Tribes (Wichita, Keechi, Waco, and Tawakoni) (the "Tribe") possesses substantial inherent sovereign powers and has exercised those powers since time immemorial; and
- WHEREAS,** the Tribe has a duly established Tribal Government recognized by the Secretary of the Interior; and
- WHEREAS,** Article V of the Wichita Governing Resolution authorizes and empowers the Wichita Executive Committee of the Wichita and Affiliated Tribes to act in all matters of business on behalf of the Tribe; and
- WHEREAS,** in order to facilitate the process to distribute the 2025 Children's Clothing Program, the Wichita Executive Committee has decided to utilize a Purchase Card from Arvest Bank, and
- WHEREAS,** the Purchase Card Program requires the purchase of a Certificate of Deposit in an amount to cover the costs of these payments, and
- WHEREAS,** The Wichita Executive Committee has decided to utilize \$107,800 from the Tax Commission and \$15,500 from the Elder Payment balance from 2024 for the purchase of the Certificate of Deposit, and
- WHEREAS,** The application form has been approved for distribution in order to process the Children's Clothing Assistance in a timely manner.

NOW THEREFORE BE IT RESOLVED, the Wichita Executive Committee hereby approves the purchase of a Certificate of Deposit in the amount of \$123,300.00 and the participation in the Purchase Card Program with Arvest Bank.

NOW THEREFORE BE IT FINALLY RESOLVED, the Wichita Executive Committee of the Wichita and Affiliated Tribes hereby authorizes the President or Vice President in the President's absence to take all actions and execute all documents necessary to carry out the intent and purpose of this resolution.

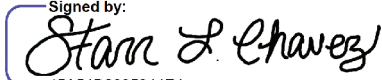
